A motion was made by Supv Sweeley/ 2^{nd} McClain, to accept the Treasurer's Report, pending audit. Motion carried unanimously. By motion of Supv Sweeley/ 2^{nd} McClain, it was unanimously agreed to pay the bills as listed on the Expense Report for a total of \$23,915.88, including Sewer Expenses of \$4,868.46.

PUBLIC HEARD:

- 1) E. Gallup asked for a brochure on E-One grinder pumps, questioned road boring permits and why Foster Township didn't build their own treatment plant. He also asked about Road Master salary.
- 2) J. Stratton read a statement from the Citizen Committee regarding our roads, ditches, mowing and brush.
- 3) M. Vandermark noted activity at the Cyclone treatment plant and questioned the cost savings of having two treatment plants. She asked Melissa to find out why Foster Township didn't build their own treatment plant.

COMMUNICATIONS:

- 1) The PSATS news bulletins were received, Chapman noted that the 2015 IRS mileage rate is 57.5 cents per mile. Also Labor and Industry established 2015 bid limits increased from \$19,100 to \$19,400 and telephone quotes increased from \$10,300 to \$10,500.
- 2) Supv. McClain and Sec'y Smith expressed interest in attending the 93rd Annual PSATS Educational Conference & Trade Show being held April 19-22, 2015 in Hershey.

OLD BUSINESS:

- 1) a. A motion was made by Supv Sweeley/2nd Chapman, to approve payment of Requisition No. 12. Motion carried unanimously. b. Bloomgren presented Sewer Project Phase II, Memo No. 52.
 - c. Progress is being made with the Inter-municipal Sewer Agreement with Lafayette Township.
- 2) A motion was made by Chapman/2nd McClain to adopt Ordinance No. 90, Authorizing the Participation of Keating Township in the PSATS Unemployment Compensation Group Trust Pursuant to the PA Intergovernmental Cooperation Law. Motion carried unanimously.
- 3) The annual Chapter 94 Rules & Regulations of the PA DEP- must be completed before January 31, 2015.

NEW BUSINESS:

- 1) It was determined to retain the amount of the Township Treasurer's 2015 bond of \$800,000. Supv. Chapman will sign the Certificate of Election for Treasurer Smith.
- 2) The Annual Occupational Health System's Commercial Driver's License (CDL) Contract and CDL Agreement were signed by Chairman Chapman, via motion of Supv. Chapman/2nd Sweeley. Motion carried unanimously.
- 3) A motion was made by Supv. Sweeley/2nd Chapman, to adopt Resolution No. 2015-A, accepting SEO Fantaskey's 2015 Fee Schedule for the Sewage Enforcement Officer. Motion carried unanimously. It was noted there were several increases and additions.
- 4) A copy of DEP's letter sent to Smethport Borough regarding the Smethport Flood Protection Program inspection was received. The inspection produced a "Minimally Acceptable" rating. Keating's involvement with the project relates to mowing along Potato Creek.
- 5) No interest was shown for the upcoming workshop.
- 6) It was unanimously agreed, by motion of Supv. Sweeley/2nd Chapman, to issue a development permit to V. Cover.
- 7) It was announced the Township Auditor's Organizational Meeting will be held on Tuesday January 6, 2015 at 6pm.
